Kim Wyman, a registered Republican, began her career in elections in Thurston County, Washington, more than 30 years ago as the election director. Following her service as the county's auditor, which is also the chief local election official, Kim served as Washington's secretary of state from 2013 to 2021. When elected, she was just the second woman to serve in that position in Washington.

During her extensive career in elections, Wyman has been consistently committed to improving election administration and upholding accessibility, security, and accuracy of election processes. As a result of Kim's **bipartisan** leadership, she was appointed by President Joe Biden to serve as senior election security advisor for the Cybersecurity and Infrastructure Security Agency.
